

We, **Science Centre** ("company") will supply you, with goods on these terms unless we have agreed in writing to different terms.

Price

1.1 Unless we agree otherwise, our prices are subject to change without notice.

Unless specified in our invoice, all Prices exclude freight, packaging, delivery and travel charges, and goods and services tax, all of which the customer must pay.

Payment

2.1 Unless otherwise agreed, payment for Goods and/or Services shall be made in full on or before the 10th day of the month following the date upon the invoice.

2.2 Should you fail to pay your invoices by the due date set out in clause 2.1 above then:

2.2.1 We may require you to compensate us by making payment to us on demand of interest (as liquidated damages) on the amount due from the due date until the date of payment at a rate equal to 15% per annum

2.396 Prior to the supply of Goods and/or Services, we may require a deposit from you.

Quotation

4.1 Where a Quotation is provided by us for Goods and/or Services:

3.1.1 Unless otherwise agreed, the Quotation shall be valid for thirty (30) days from the date of issue;

3.1.2 The Quotation shall be exclusive of GST unless otherwise stated in writing; and

3.1.3 We reserve the right to vary the Quotation due to any circumstances.

Title and Risk

5.1 Goods are at your risk as soon as they have been delivered to you.

Orders and Delivery

6.1 All orders are to be made by your nominated representative in writing and shall include all specifications, quantities and any requirements for time or location for delivery.

6.2 If you have specified a delivery date, we will try to deliver the Goods and/or Services to you by that date. However:

6.2.1 we will be entitled to deliver the Goods and/or Services to you after the agreed delivery date or cancel the order without being liable to you in any way if the delay in delivery is due to causes beyond our reasonable control; or

6.2.2 we may deliver the Goods to you by installments in any quantities and each delivery will be a separate contract independent from the other deliveries.

6.3 You may not refuse to accept delivery of Goods unless we have otherwise agreed in writing.

5.4 We will only be liable to you for shortfalls, losses, damage or failure to meet specifications where you have notified us of those matters within seven (7) days of taking delivery.

6.5 Goods which do not meet your specifications may not be returned to us unless:

6.5.1 we have agreed in writing that they may be returned; and

6.5.2 you have not had the Goods for more than 14 days; and

6.5.3 the Goods' containers neither been opened nor their packaging has been damaged in any way; and

6.5.4 you will pay for the cost of returning the Goods; and

6.5.5 you will pay our handling fee.

Amendment

6.1 We may amend these conditions at any time. Notice of any amendment shall be advised to you on our website and such amendments will be deemed to have taken effect and been accepted by you from the time of publication upon our website.
